### WARNING – NOTE:

1. *The Buyer has the right to withdraw from the contract within 14 days from the day when the Goods are delivered, to the Buyer or a third party designated by the Buyer (carrier not included) and expires on the 14th day from the day of receipt of the Goods.*
2. *The Buyer is obliged to return the Goods to the Seller, without delay, and no later than within 14 days from the day when he sent the withdrawal form.*
3. *The goods are returned at the expense of the Buyer, by sending the Goods via the courier service that delivered the goods to the Buyer (Post of Serbia or DHL) to the address of the Seller, Čubrina 1, Belgrade.*
4. *The returned goods must be unused, undamaged and in the original package, they must contain the tag in the same way as when the Goods were received and the original invoice must be attached*
5. *Refund of payments received by the Seller from the Buyer will be made within 14 days from the day when the Seller received the withdrawal form, in the same way as the payment of the price by the buyer.. The seller can postpone the refund until he receives the returned goods or until the Buyer doesn't deliver the evidence of sending the Goods( depending which comes first).*
